CONTEST RULES & REGULATIONS

1. To Enter: (a) Fully complete a Toronto Association Business Improvement Area (TABIA) Spray 'N Save application form. The TABIA Spray 'N Save application forms can be obtained through your local BIA office or through the TABIA website at www.toronto-bia.com/. (b) Only full service restaurants are eligible to enter: establishments where patrons order while seated and pay after eating, and do not use disposable utensils. These establishments may sell alcoholic beverages, provide take-out services, operate a bar, or present live entertainment in addition to serving food and non-alcoholic beverages. Includes full-service establishments known as fine-dining restaurants, family restaurants, and restaurant-bars. Please mail TABIA application forms to Enbridge Gas Distribution, P.O. 2. Limit one entry per commercial address. Additional entries will be disqualified. All entries become the property of Enbridge Gas Distribution Inc. ("Enbridge"), which assumes no responsibility for incomplete, lost, delayed, destroyed or misdirected entries. No entries will be returned. Employees or members of the immediate family of, or those domiciled with an employee of Enbridge, its affiliated companies, prize suppliers or promotional agencies engaged in connection with this contest are not eligible to participate in this contest.
3. Contest entry is limited to residents of the province of Ontario who are 18 years of age and older and have an Enbridge Gas Distribution Inc. ("Enbridge") commercial rate 6 account and using a natural gas water heater.
4. All TABIA Spray 'N Save application forms must be received by 1:00pm Friday July 15, 2005 to be eligible for the draw.
5. Two natural gas patio heaters (approximate retail value \$1600.00) are available to be won. Installation not included. Winners are responsible for all installation costs. All eligible TABIA Spray 'N Save application forms received by 1:00PM Friday July 15, 2005 will be entered into a draw. (Offer not available to residential customers).
6. A random draw will be made on July 18, 2005 at 500 Consumers Road, North York, Ontario from all eligible entries that are received prior to the time of the draw closing. Odds of winning depend on the number of eligible application forms received. No correspondence will be entered into, except with the selected entrants. The selected entrant will be contacted at the telephone number provided by the entrant on the application form within three (3) business days. If a selected entrant cannot be reached personally, without leaving a message, within ten (10) business days of the first phone call made and after a minimum of three call attempts by the contest administrator, or if the selected entrant does not otherwise comply with these Contest Rules, they will forfeit their prize claim and another entrant will be selected.
